Following a very successful Annual Convention in July this year, LNP members have been busy contributing to debates at branch, SEC, FDC and Policy Standing Committees. The results are the resolutions printed in this booklet.

The motions in this "State Council Agenda Booklet" will provide the basis for constructive debate and those resolutions carried will provide the impetus for further policy development and provide a roadmap for our State and Federal Parliamentary teams.

#### AGENDA COMMITTEE'S ROLE & MEMBERSHIP

Under our Party's Constitution the Agenda Committee is charged with the phrasing of notices of motion and the consolidation of such notices of motion which are similar in interest or intent.

The Agenda Committee would like to put on record their thanks to those members who spent many hours ensuring their resolutions were carefully researched and had the necessary supporting documentation provided on the appropriate form. It really is important that the correct format is followed. If you have any questions please do not hesitate to contact me or talk to your Regional Chair.

As Chair of the Agenda Committee I have been ably assisted by Deputy Chair Vicki Morris along with Richard Williams, Wendy Armstrong, Steven Mammarella and Victoria Shenstone. Of course the wonderful team in the Secretariat led by Angela Awabdy have ensured the committee have been provided support needed and no request was too hard.

#### STANDING ORDERS

In order to ensure the debate flows and every State Councillor can contribute to the debate in an orderly fashion, it is always worthwhile to have a quick look at the standing orders prior to each Convention or State Council. As the Flight Attendants remind us, even if we fly regularly we need to pay attention to the safety warning as we might sit in a different seat. You may have been attending Conventions, State Council and other party meetings for many years however; a different situation in a debate might confront you, so a quick refresh of the Standing Orders will make life easier for everyone.

# BIG CHANGES RE CLOSING DATE FOR NEXT YEAR'S CONVENTION:

Now I have your attention, I can confirm that next year's convention will be held mid-year - and therefore the closing date will be 30 days prior to the convention. This is and has been the cut-off date for as long as I remember. Before every State Council and Convention there is always the last minute rush. Can I ask all State Councillors to please ensure their SEC or FDC has a meeting scheduled in May 2016. Don't leave your resolutions to your June meeting as they may miss the deadline. By having a meeting in May any resolution passed and submitted immediately with the appropriate minutes and documentation will be received in plenty of time for inclusion in the 2016 Convention Programme.

In closing I would like to thank all those party members I spoke to during the preparation of the agenda and their willingness to assist with this process. As volunteers we all spend time that would have been allocated to our family, friends or other interests and the willingness to pitch in and work towards our common goals is to be commended.

I look forward to seeing you all in Kingaroy.

# **Standing Orders**

These Standing Orders shall be applicable to all meetings of Party Units.

ATTENDANCE REGISTER AND VOTING TICKETS	1	(a) Each Member shall sign the attendance register and having done this the Member will be issued with a voting ticket. Except where a ballot is required, a Member entitled to vote will be required to show the voting ticket to register a vote for or against a notice of motion.
		(b) Each Member shall sign the attendance register for a session at which a ballot is to be conducted (providing it is in advance of the designated closing time for the issue of ballot papers in that session) and shall be given the relevant ballot paper or papers.
CHAIRMAN	2	The President or Vice-President or Chair or Deputy Chair of the Party Unit concerned (as the case may be) (or in the absence of such persons, a Member appointed by the meeting) shall be Chair.
	3	When the Chair rises to speak any Member on his feet shall resume his seat.
CASTING VOTE	4	The Chair shall have the right to a deliberative vote and whether or not he casts a deliberative vote to a casting vote on an equality of votes.
RULINGS BY CHAIRMAN	5	Before ruling on a matter of interpretation of the Constitution, By-laws or these Standing Orders the Chair may request a Member or Members present to make submissions thereon.
DISSENT	6	A motion of dissent from the ruling of the Chair shall lapse unless seconded. Discussion on a motion of dissent shall be limited to six minutes, the mover and the Chair, each having no more than three minutes to put his case.
PARTICIPATION IN DEBATE	7	The Chair may at his discretion vacate the Chair to participate in the debate.
COUNTING OF VOTES	8	The Chair shall declare a motion carried or lost. Should the Chairman's declaration be disputed by ten or more voting delegates present, or should the Chair so require, a count of votes for or against the motion shall be taken provided that a request by such voting delegates shall be made immediately after the Chair shall have made his declaration.
TELLERS AND SECRET BALLOTS	9	In the event of a count of votes being required in accordance with the preceding Standing Order, the Chair may appoint two or more tellers to count the votes for or against the motion then before the Chair and report the result to the Chair. Should 50% of the voting delegates then in attendance request a ballot, a secret ballot shall be taken. The Chair may appoint two or more tellers to count the ballot papers and report the result to him.
MOVING OF MOTIONS	10	Unless the meeting otherwise resolves, a motion standing in the name of a Party Unit shall be moved by a delegate from such Party Unit or by a member of State Council, being a member of the Party Unit in whose name it stands, and such motion does not require to be seconded. If not moved during a day session other than on a Saturday or Sunday a motion shall be called again in the succeeding evening session and if not then moved the motion shall lapse.
AGENDA	11	Subject to Standing Order 10 the Agenda as accepted by the meeting in receiving the Agenda Committee Report shall be proceeded with in the order in which it is set out.

# **Standing Orders**

URGENT MOTIONS	12	If the Agenda as accepted by the meeting provides a time for the consideration of urgent motions, any Member may notify the Chairman of the Member's intention to propose such a motion prior to the time specified for commencement of such business, or such earlier time as the meeting may determine. At the time specified for commencement of such business, the Chair shall advise the meeting of the motions which have been duly notified. The motions will be called on for debate in the order determined by the Chair. The mover of each such motion shall have one minute to explain the urgency, after which the meeting shall determine by a simple majority whether the motion should be accepted for further discussion. If the meeting determines that the motion should be accepted, debate will proceed as provided in these Standing Orders, but otherwise the motion shall lapse.
RIGHT TO SPEAK	13	Each Member shall have the right to speak; (a) once on any substantive motion before the Chair; and (b) once on any amendment.
OPPOSITION TO MOTIONS	14	The Chair shall read all motions before the Chair and inquire whether there is any opposition to the motion and if there is none he may, at his discretion, put the motion to the vote without further debate.
TIME LIMIT FOR MOVER OF MOTION	15	The mover of a motion shall be allowed three minutes to introduce the motion and at the conclusion of discussion as set out in Standing Order 28, even though his original motion shall have been amended, a further two minutes for reply to wind up the debate. There shall be no right of reply attached to the moving of an amendment.
TIME LIMIT FOR SUBSEQUENT SPEAKERS	16	Speakers subsequent to the introduction of the motion shall be limited to two minutes.
DISCUSSION TIME PER AGENDA ITEM	17	Discussion of any item on the agenda may continue for twenty minutes, but on a motion carried by not less than 75% of those in attendance there shall be an extension of 10 minutes making a total of 30 minutes for discussion.
SUSPENSION OF STANDING ORDERS	18	No motion to suspend Standing Orders or any of them shall be moved unless on a matter of urgent necessity. The Member proposing any such motion shall first state it and the reasons why such motion should be forthwith considered. He shall be allowed three minutes to explain the urgency whereupon the motion for suspension shall be put forthwith and shall be carried by not less than 75% of those then in attendance.
RIGHT TO SPEAK	19	A Member desiring to speak shall rise in his place and address the Chair. On receiving the Chair's recognition he shall announce himself by name and state the capacity in which he attends. Once a Member has received the Chair's recognition any other Member on his feet shall resume his seat.
EXTENSION OF TIME	20	An extension of time amounting to 50% of the time provided in Standing Orders 15 and 16 may be granted to a speaker on a motion carried by not less than 75% of those then in attendance.
EXPIRATION OF SPEAKER'S TIME	21	A speaker shall be warned by the sounding of a bell one minute prior to the expiration of the time to which the speaker is entitled in accordance with these Standing Orders. A bell shall be sounded a second time when the speaker's time has expired and the speaker shall immediately cease to address the meeting.

POINTS OF ORDER	22	A Member may rise to a point of order, which shall be related to procedure and/or relevance, but not to argument, when the speaker called to order shall resume his seat. The Member rising to the point of order shall state concisely within one minute the point of order whereupon the Chair shall give his ruling and subject to that ruling the person speaking when the point of order was raised shall be entitled to proceed.
SECONDING OF MOTIONS	23	A motion other than a Notice of motion referred to in Standing Order 10 shall be seconded and if not seconded shall lapse.
WITHDRAWAL OF NOTICES OF MOTION	24	A notice of motion may be withdrawn only with consent of the meeting.
AMENDMENTS	25	A Member may move to amend a substantive motion before the meeting, but before moving the amendment the mover shall hand the proposed amendment in writing to the Chair. Such amendment shall be seconded and if not seconded shall lapse.
LAPSED MOTIONS OR AMENDMENTS	26	A motion or an amendment which has lapsed shall not be considered again during that meeting.
NOTICE OF, OR FORESHADOWED, AMENDMENTS	27	During the consideration of an amendment a Member may give notice of or foreshadow a further amendment specifying its terms, but there shall be no discussion on such further amendment until the amendment then under consideration is disposed of.
AMENDMENTS	28	Discussion of any amendment to a motion shall be considered as debate on the original motion, taking place before the mover of the motion exercises his right of reply.
MOVING THAT QUESTION BE NOW PUT	29	Any member who has not spoken to the question may move at any time, but so as not to interrupt a member addressing the Chair, that the question be now put and thereupon such motion upon being seconded may be put to the meeting at the discretion of the Chair. Upon the motion that the question be now put being carried, the mover of the original motion shall have the right of speaking for three minutes after which the question shall, without further discussion, be put.
OTHER PROCEDURAL MOTIONS	30	Any Member may move a procedural motion, which upon being moved and seconded shall supersede debate on the substantive motion under discussion. The Chair shall have a discretion as to whether or not to accept the motion. There shall be no right to speak in favour of, or against, a procedural motion other than a motion that the substantive motion be referred to some other Party Unit. The mover of the procedural motion shall have the right to speak for 2 minutes in favour of it, after which the mover of the substantive motion, or if the mover declines, some other member, shall have the right to speak against it for 2 minutes, after which the motion shall be put. This Standing Order does not apply to a motion of dissent from a ruling of the Chair, or a motion that the motion be put.
PERSONAL EXPLANATIONS	31	Any Member may at any time make a personal explanation not exceeding two minutes to explain himself in regard to some material part of his speech which has been misquoted or misunderstood, but in such case he shall not introduce any new matter or interrupt any Member addressing the Chair.

## **Standing Orders**

PRESENTATION OF REPORTS	32	Chairs of Committees and Senators presenting reports will be allowed three minutes within which to move the adoption thereof and each speaker to a report shall be limited to two minutes. The time limit for the discussion of such reports shall be at the discretion of the Chair unless time limits have been prescribed in the Agenda Committee report.
RECONSIDERATION OF DECISIONS	33	No decision of State Convention shall be reconsidered during that Convention except as provided by Standing Order 18.
BALLOT PAPER ORDER	34	Names of nominees on ballot papers shall appear in order determined by lot. The Chair shall appoint scrutineers.
CHAIRMAN FOR ELECTION OF PRESIDENT	35	The Immediate Past President, or in his absence such other person as the Chairman shall appoint, shall occupy the Chair for the election of the President
UNCOMPLETED BUSINESS	36	Any business not completed or debated in the course of State Convention shall lapse, and be referred to the Policy Standing Committee for review.
QUESTIONS	37	Questions may be directed to the Chair regarding procedure and/or interpretation. No questions shall be directed to speakers concerning argument except at the discretion of the Chair.
OTHER PROVISIONS	38	Where a point is not covered in these Standing Orders, it shall be governed by the procedures stated in the current edition of Horsley's Meetings Procedure Law and Practice.



## Acting President's Report Gary Spence

Welcome to this gathering of the LNP State Council in Kingaroy. It's the first time this event has been held in the Wide Bay Region and continues the LNP tradition of holding State Council meetings in regional centres as part of our commitment to be the Party for all Queenslanders. I am sure you will find this meeting worthwhile and enjoy the social functions that have been planned around it.

This meeting of State Council comes as we near the end of a year that can only be described as one of change and adjustment for the LNP.

The implementation of recommendations of the Borbidge-Sheldon Review is having a positive impact on the Party organisation and led to increased engagement with our dedicated members.

State Leader Lawrence Springborg and his parliamentary colleagues deserve our thanks for their commitment to increase the involvement of members across the state.

### State Director's Report Lincoln Folo



Welcome to the last major event on the LNP calendar for 2015. I'd like to express my thanks to all the members of our Party I've met since my appointment in late July for their encouragement and enthusiasm for the LNP

This weekend will see a new President and Vice President for the LNP, after the retirement of Bruce McIver who served in leadership for a decade firstly with The Nationals and then the LNP. I'd like to record the thanks of the LNP staff to Bruce and Chris for their support and dedication over many years.

We now look forward to the new team leading us to the federal election next year.

In my travels throughout Queensland a consistent theme has been the desire to grow the membership of the LNP. I believe that we must do more to share the values of the LNP and ask everyone who shares them with us to join our Party. Because we need more members — not because more members is an outcome in itself, but with more members we have greater community engagement. We can be more representative and foster the diversity of skills, ideas and experience that is one of our great competitive advantages over the Labor Party in a membership that is bound by shared values. LNP members should be encouraged by our recent membership growth. The feedback provided to our membership team indicates a number of reasons for joining. They are:

- 1. Change of federal Liberal Party leadership to Malcolm Turnbull
- 2. Frustration towards the State Labor Government and the unwinding of Newman Government policies that were working for Queensland
- 3. They were asked to renew after having lapsed

The number one reason many people don't give to or join a cause is because they have never been asked. We can overcome this by being a Party of action and asking.

This has been a year of great challenge, frustration, and disappointment for many people within our Party and supporters across Queensland. But as it draws to a close we are also seeing fresh opportunity, energy and optimism for Australia and conservative politics.

This State Council brings to a conclusion a month of action that we have undertaken across the LNP, engaging SECs, FDCs and Regions to test some new campaign techniques, a comprehensive membership survey, with over 1800 responses, and a membership training and recruitment drive. We have also launched the local supporters program which if embraced by SECs has the potential to provide realistic long term campaign funding.

In Malcolm Turnbull we have a new Prime Minister, who in the space of less than three months has changed the tone and trajectory of our federal political fortunes. The Prime Minister has reshaped the debate and the community is responding strongly to his message of growing the economy, developing new opportunities and working towards a better future.

This message is well aligned with Lawrence Springborg's vision of unleashing the potential of Queensland. Lawrence and his team have worked tirelessly to re-engage with stakeholders throughout Queensland and share their optimism for the future and desire to unleash potential across the state. He has also expressed his concern that Labor is holding Queensland back. With no plans that will grow our economy Labor is only rolling back the reforms and policies that made Queensland a safer place to live and easier place to invest.

We must continue to support the State LNP team in holding Labor to account and work with them to share their plans for making Queensland great

With Council elections in March and the next federal election due within 12 months, the year ahead will be exciting, it will be challenging and if we work together it will be successful.

State Report

Lawrence Springborg

Leader of the Opposition

In the coming week we will mark 300 days since the State Election. For your LNP parliamentary team this means 300 days of travelling thousands of kilometres and listening to thousands of Queenslanders across our great state.

In these 300 days Queenslanders have been able to contrast an LNP that believes passionately in unleashing the potential of all Queensland; against a Labor Government, propped up by the disgraced Billy Gordon and union bosses, that is holding Queensland back.

During these 300 days your parliamentary team has re-engaged with Queenslanders like never before.

We have listened to Queenslanders tell us about the errors made that saw us lose office. And we have listened to Queenslanders tell us of the successes we drove and achieved that saw the LNP substantially outpoll every other political party at the ballot box - to become the only party to secure the first vote of more than a million Queenslanders.

Everywhere I go people who didn't vote for the LNP tell me that they gave the Labor government goodwill. But after nine months in office there are still are no plans for jobs or the economy, and no plans for frontline services.

They also tell me they are concerned about who exactly controls this Labor Government with Billy Gordon, extreme Greens and factional and union bosses enjoying unprecedented access and unrivalled influence. Already union bosses have been able to secure over 70 one-on-one meetings with Ministers to personally direct the passage of laws including those that will give them access to the personal information of tens of thousands of government employees.

Equally, as your LNP team travels throughout our State, Queenslanders are telling me they want the next LNP government to continue its focus on sound economic management that allowed us to reign in Labor's debt, and lay the foundations for new jobs. They recognise that astute economic management allowed us to re-invested in frontline services such as the LNP's "Wait Time Guarantee" that ensured surgery on time; a record number of police officers; and our Great Teachers = Great Results funding package.

When it comes to community safety, Queenslanders are also telling me loud and clear that they do not support Labor's plans to dilute the fight against the scourge of illegal bikie activity, that was so effectively curtailed with the LNP's VLAD laws.

In our regions, Queenslanders are disappointed that Labor is unwinding the LNP's successful Royalties for Regions program; and they are fearful about the impact on land values and business models — particularly at a time of severe drought — that Labor's promise to kowtow to extreme greens on vegetation management laws will have.

As the LNP works to secure the support of Queenslanders to form government in this state, it is important that while we must learn the lessons from defeat, we also do not turn our back on the many successes that Queenslanders will expect us to pick-up from and see through

We offer an experienced and competent team capable of unleashing the state's full potential; in contrast to Labor's inexperience and indecisiveness that is holding Queensland back.

This weekend the LNP's State Council also makes another decision fundamental to our return to state government and fundamental to retaining federal government: we choose a new President whose leadership must ensure we maintain a strong, active and engaged organisation.

Bruce McIver has been President of our party since its inception in 2008. He shared a vision for one united party and helped steer that vision to fruition. He has led our organisation through its formation and through the highs of election wins and the lows of election defeats.

In that role it has required 100% energy; 100% commitment; and 100% dedication to our members and our values. To do that has also required 100% support from his wife Chris.

On behalf of our thousands of members I extend thanks and deep appreciation to both.

# **Brisbane City Council Report** *Cr Graham Quirk, Lord Mayor of Brisbane*



Over the past four years my team and I have worked towards making Brisbane a better place to live, invest and visit.

I believe that we have made remarkable progress towards that goal. In recent times Brisbane has transitioned from a city that aspired to be 'New World,' to one that is regularly singled out as a city to watch. Whether it is US tech guru and Cisco director Gordon Feller talking up Brisbane's potential to become the world's "smartest" city or the Lonely Planet guide describing Brisbane as the nation's 'coolest' and 'most under-rated' city, our potential and the sense of optimism about the direction Brisbane is heading in is both real and powerful.

I have set out an ambitious agenda to become widely recognised as a business friendly, digital city which encourages investment and local job creation. Brisbane was only the second city in the world to appoint a Chief Digital Officer who helped create a digital strategy to empower local businesses. We run the popular Brisbane Business Hotline '133 BNE', which provides a single point of contact for local businesses.

There is still more to be done and plenty of exciting projects underway if we are to maintain this momentum. Earlier this year I announced a major \$11 million upgrade of the Edward Street retail precinct.

This upgrade is progressing well and after a period of consultation a visioning document was released last week. It is my hope that this process will add a new public space that is vibrant, colourful and will contribute towards the economy and function of the city. I believe that this upgrade will be a huge boost for Brisbane's CBD retail sector and will complement well the new Queen's Wharf development.

My administration has not forgotten to look after the basics. We have invested record amounts on bikeways, public transport and road

resurfacing in our suburbs. A record \$100 million has been allocated in this year's budget to help keep our suburban roads smooth and I am pleased that Brisbane continues to boast the most modern bus fleet in Australia.

It is amazing that the Labor Party, when last in office, only had air conditioning in one third of buses. We have come a long way since then with our fleet now fully air conditioned and low floor disability compliant. Successive LNP administrations have added over 1,100 new buses to the fleet since 2004.

We are continuing to focus on infrastructure with projects like Kingsford Smith Drive, Wynnum Road Stage 1 upgrade and the four laning in each direction of the Inner City Bypass. These are all high on the agenda with funds fully allocated.

Few people realise that we are also Australia's Most Sustainable City. Our commitment to 100% green power, innovative energy saving solutions and litter reduction saw Brisbane recognised as Australia's Most Sustainable City by the Keep Australia Beautiful organisation in 2014. We recently won the 2015 Queensland award, so we're in the running for the national prize again. This is a fantastic achievement and is a true testament to our city's growing reputation as a leader in sustainability, litter prevention and removal and energy innovation.

Brisbane is on the right path. My team and I want to keep this momentum going and with a Council election months away I hope that we can rely on your continued support.
